§ 3

Free Return

If the foal resulting from the covering does not survive 24 hours after its birth, is still born or the foetus is resorbed, the mare's owner has the right to have the mare covered again the following breeding season.

A condition for the right to have the mare covered again is that the mare's owner shall inform the stud farmer immediately of the loss of the foal or on request shall provide the veterinary certificate. The right to have the mare covered again is excluded if the loss of the foal is the fault of the mare's owner or a third party.

In the event of a free return, the frozen semen tax and the portage for semen shipment have to be paid once again by the mare owner. The stud fee does not fall due for payment.

§ 5

Terms of Shipment

The shipment of the semen ensues right after complete payment.

The portage for semen shipment has to be covered by the mare owner. The portage is directly invoiced by the stud farm and is due right after bill receipt.

A maximum of 4 portions will be shipped.

The frozen semen has to be stored and processed by competent staff only. The mare owner is responsible for adequate and orderly processing of the semen.
